At the Shoot You, or someone authorized by you, should be present at the shoot to discuss important elements of the property or areas not to be photographed. The photographer will make reasonable effort to remove litter, stray objects etc. from rooms, however please note this does not include making beds or arranging furniture. We will provide a checklist of items to fix, for you to provide to the seller to complete for the best results. Agents are expected to have the property ready and staged prior to the shoot.

All properties will be shot AS IS.

Payment is due at time of the shoot on location.

After the Shoot, After the images have been shot, the photographer will edit the shoot and select the best images. These will be optimized for quality and delivered to you within 48 business hours, unless otherwise specified.

Video Tours do take longer than photography. Videos will be delivered in 1-2 business days depending on details in video. If a script and voice over is ordered it can take up to 5 business days.

Cancellation, No-Show and Inclement Weather Policy. If cancellation or rescheduling is necessary, please do so with a minimum of 24hrs notice. Any shoot canceled within 24hrs of a confirmed appointment is subject to a \$100.00 cancellation fee. The full price of the shoot will be charged to any cancellation within 2 hrs. of the scheduled time.

Arriving late beyond 30mins to an appointment will be considered a cancellation, and will be billed at the 1/2 rate of the shoot. Every effort will be made to accommodate a reschedule. In the event of inclement weather a reschedule of the shoot will be at the earliest time possible.
